EXPERIENCE

In the Family Court Nick represents parents and other family members and the children through their children's guardians and adults who lack capacity through the Official Solicitor as well as local authorities. He also represents Health Boards and Trusts in medical treatment cases. He believes that this range of clients ensures that he retains an insight into the needs and pressures on each of the parties and how this may affect their views on a child's welfare.

In the Court of Protection Nick works for P through litigation friends and ALRs as well as for other family members, local authorities, and health care bodies. His work includes the deprivation of liberty, medical treatment, and welfare issues as well as the role of deputies and attorneys appointed under lasting powers. He advises and represents parties including deputies and attorneys in property and financial affairs applications involving approval of gifts and statutory wills.

Nick accepts Direct Access instructions in both Family and Court of Protection work.

The breadth of Nick's experience is reflected in him recently being instructed in cases on access by the press to material in care cases, access to adoption and social care records, inquests concerning social services, liability of local authorities for damages for breaches of Human Rights and negligent discharge of functions, judicial reviews on the support provided to grandparents and others caring for relatives, "boundary disputes" between public bodies in children services and education services and the validity of marriages and divorces.

Nick is a contributor to Legal Action and Family Law Week commenting on recent cases. He lectures on Court of Protection and care and adoption issues and provides training for children's advocates, social workers, and other lawyers.
