OVERVIEW

Kyle has a strong reputation as a specialist in Court of Protection and children cases. Shortlisted as Junior of the Year, Court of Protection in the Legal 500 Bar Awards 2024 and ranked as a leading junior in both practice areas in the Legal 500, it is noted that he is “exemplary in his advocacy”, and his “knowledge in his field is remarkable”. Kyle leads the Court of Protection team in Chambers.

Kyle spent almost 3 years employed as counsel at Great Ormond Street Hospital for Children NHS Foundation Trust, a world leading children’s hospital based in London. In that role, he regularly represented the hospital in the High Court in relation to serious medical treatment applications, as well as in the Court of Protection.

Given his experience at GOSH, Kyle is well placed to act in cases which concern serious medical treatment or require forensic examination of medical evidence. Kyle regularly appears in the High Court, often against leading counsel.

Kyle also sits part time as a Recorder in the Family Court and a Judge of the First Tier Tribunal, sitting in the Mental Health Tribunal. He is able to bring his expertise from those experiences to the cases in which he is instructed.

Court of Protection

Kyle has a strong reputation in the Court of Protection, regularly instructed in complex cases which involve issues such as serious medical treatment, fluctuating capacity, and novel points of law. He takes instructions from P (the person who lacks capacity) by their litigation friend (often the Official Solicitor), NHS Trusts, local authorities and family members.

Regularly appearing before Tier 3 judges and having been instructed by the Official Solicitor in the Court of Appeal, Kyle has acted in a number of cases which have clarified or advanced the law in the Court of Protection. He is particularly sought after for cases involving young adults, where there is transition from children's services to adult services.

Kyle also represents vulnerable adults who are at risk of forced marriage, and where there are difficult questions over their capacity to engage in sexual relations and marriage.

Kyle sits as a Recorder in the Family Courts and is therefore very well placed to represent all parties within public law children proceedings.

Public Children

Regularly instructed in serious public children cases, most often involving allegations of serious non-accidental injury, sexual abuse, or the risk of forced marriage, Kyle's experience working in a hospital makes him well placed to consider difficult and complex medical evidence, and to challenge experts on their opinions.

Kyle regularly represents vulnerable parties through litigation friends and the Official Solicitor. His knowledge of Court of Protection issues complements his work with vulnerable parents well, and he had been described by solicitors as 'going above and beyond what is expected of counsel'.

Kyle sits as a Recorder in the Family Courts and is therefore very well placed to represent all parties within public law children proceedings.

Private Children

Kyle has significant experience acting in private children cases, including complex fact-finding hearings and matters of specific issues. He is particularly sought after in cases where one party may lack capacity to litigate, and where there are disputes about children's medical needs. Kyle takes is pragmatic, yet robust where necessary. He has been praised, in particular, for his client care and responsiveness. He will make decisions to place his client in the best position to succeed in litigation, whilst being mindful of costs.

CASES

[Re Care Proceedings \(Wishes and Feelings of a Child Aged 14\) \[2025\] EWHC 169 \(B\)](#) - Representing a local authority in care proceedings where the primary issue was the mother's complex mental health needs. Kyle persuaded the court to make a care order, arguing that the mother's risk of relapse in her mental health was significant, in circumstances where the 14-year-old child's expressed wishes and feelings were to return to live with her mother.

[An NHS Trust v G \[2024\] EWHC 2207 \(Fam\)](#) – Acting for an NHS Trust in a case which considered the limits of parental consent to treatment for significant psychiatric conditions, concluding that the MHA Code of practice is wrong and requires updating.

[J v Luton Borough Council \[2024\] EWCA Civ 3](#) – Appeal acting on behalf of the Official Solicitor against a best interests decision that P should not travel to Afghanistan.

[A London Borough v S \[2023\] EWHC 339 \(B\)](#) - Representing Great Ormond Street Hospital as an intervener. Kyle was instructed part-way through the hearing, where most parties were represented by leading counsel. Kyle successfully argued that injuries were not caused by the Trust. HHJ Purkiss commented that:

Whilst grateful to all counsel for their assistance during the hearing and their written submissions, I would like to express particular thanks to Mr Squire for GOSH who managed, from a standing start, part-way through the hearing, to prepare his case at breakneck speed and argue it persuasively.

[Coventry City Council v MK \[2023\] EWHC 249 \(Fam\)](#) – Before Morgan J, representing P (through the Official Solicitor) in concurrent COP and FMPO proceedings where the court was required to determine the validity of a marriage which was alleged to have been contracted by proxy, and the consequent remedies given that P lacked capacity.

[Re S \(Children: Party Status\) \[2022\] EWCA Civ 1717](#) – Represented local authority as respondent to appeal where the determination of party status of a non-family member was appealed.

[Re K & L \[2021\] EWFC B39](#) – Representing a mother in fact-finding hearing concerning allegations of forced marriage. Significant criticisms of local authority’s investigatory process made by judge.

[A County Council v KK & Ors \[2020\] EWCOP 68](#) – Representing local authority in High Court proceedings before Mrs Justice Lieven relating to medical decisions concerning 17-year-old girl who mismanages her diabetes, raising ethical, moral and legal issues.
